APPROVAL OF THE COUNCIL MINUTES FROM THE 1/10/2022 MEETING.

On a motion by T. Bell, seconded by J. Garman, and voted on unanimously, Council approved the minutes from January 10, 2022 with no corrections or additions.

APPROVAL TO LIST ON MUNCIBID A WOODEN DESK FROM THE PUBLIC WORKS DEPARTMENT. DIMENSIONS: 4' LONG, 2' WIDE AND 54" HIGH.

On a motion by T. Bell, seconded by N. McGaw, and voted on unanimously, Council approved the listing on Muncibid of a wooden desk from the Public Works Department, dimensions are 4 ft. long, 2 ft. wide and 54 inches high.

APPROVAL TO LIST ON MUNCIBID A 2008 F350 V10 ENGINE MANUAL TRANSMISSION. THIS IS A 4WD DUMP TRUCK WITH A PLOW THAT WILL NOT PASS INSPECTION WITHOUT MAINTENANCE. IT DOES START AND RUN.

On a motion by T. Bell, seconded by N. McGaw, and voted on unanimously, Council approved the listing on Muncibid of a 2008 F350 Ford Truck, V10 engine, manual transmission. This is a 4WD dump truck with a plow that will not pass inspection without maintenance. It does start and run. There will be a \$6,500 reserve placed on this item.

APPROVAL OF PAYMENT TO MCTISH, KUNKEL & ASSOCIATES IN THE AMOUNT OF \$2,250 FOR PROFESSIONAL SERVICES FOR THE PERIOD FROM OCTOBER 24, 2021 TO DECEMBER 18, 2021 FOR THE PARK WALKING TRAIL.
